LOCATION

The 28th Annual Washington Street Mall Juried Fine Art Show will be held on the Washington Street Mall, and in Rotary Park, adjacent to the Mall.

ELIGIBILITY

The Juried Show is open for original work only. Media: Oil, Pastel, Acrylic, Watercolor, Photography, Ceramics, Drawing, Print Making, Sculpture, Fine Art Jewelry and Mixed Media are acceptable. Each work must be labeled with name, title and price. Artists may sell reproductions of their own original art. No clothing, crafts, furniture or kits permitted.

SPACES

Spaces for successfully juried artists will be assigned by lottery. All spaces are outdoors. Artists should bring display booths, chairs and canopies. The location and space number assigned will be noted on the letter of acceptance.

PLEASE NOTE: One space will be assigned per participant.

APPLICATION PROCEDURE

DEADLINE: June 1, 2010

Artists must submit the following:

1. Completed application with fee (Members \$75, Non-members \$110).
2. If you are new to show: A resume with 3 slides or photos of current work with titles (within the last 2 years) and 1 slide/photo of booth.
3. A self-addressed stamped #10 envelope for returning slides and photos. Slides and photos will not be returned without envelope.
Previous participants need not submit slides/photos.
4. Applications received after June 1st, will be placed on a waiting list.

FEES

Space for a 2 -day show is \$110 for Non-members and \$75 for Members. **No credit cards please.** The Art League does not take a commission on sales. Entry fee will be refunded if work is not accepted.
Deadline for cancellation is August 1st.

RESPONSIBILITIES

Artists are responsible for their own work including set-up, sales and overseeing of their own space. The Art League is not responsible for any loss or damage to works or displays. Artists are responsible for obtaining their NJ State Sales Tax ID#. Call 609-292-1730 to obtain Sales Tax Information.

Judges decisions are final.

SET-UP PROCEDURES AND RULES

Report to the Registration Table in Rotary Park near the gazebo by 8:00AM. Deadline is 9:00AM. (Do not load or unload vehicle between the traffic lights on Ocean Street and the Mall. Remove vehicle immediately upon loading/unloading). **Do not leave car unattended at any time. The Art League will not be responsible for any tickets that are distributed by Cape May Police.** All set-ups **MUST** be completed and vehicles removed by 10:00AM each day. Please remember parking meters are in effect. **All artists must close shop by 6:30 PM**
